1. Most of our teacher education candidates who successfully complete the University of Pikeville Teacher Education Program are employed in two local districts. The Chairperson of the Patton College of Education and the Supervisor of Clinical Experience regularly collaborate with district P-12 personnel to determine their needs and the role of UPIKE's Teacher Education Programs in helping meet those needs. The information obtained is used in program redesign and improvement. 2. The University Clinical Supervisor regularly meets with all P-12 teachers who serve as cooperating teachers and collaborates with them to evaluate the performances of our student teachers and to determine how we can improve our preparation programs. The University Supervisor also collaborates with several local principals to discuss ways to better prepare our teacher candidates to meet the needs of the schools. In addition, P-12 teachers and administrators serve on our Teacher Education Committee and provide input for continuous improvement efforts. 3. We survey all principals and cooperating teachers who have student teachers in their schools to collect performance data and identify any needs of the schools that are not being met.

candidates develop higher levels of mathematical thinking. Academic advisors within education inform teacher candidates of the staffing needs of the regional P-12 schools. This oftentimes includes the need for teachers of mathematics. We work closely with the P-12 schools in our region so that we can stay informed of those needs. We collaborate with faculty from the mathematics division to ensure that the curriculum is aligned with the learning needs of our preservice teachers.

All teacher education candidates are required to take and pass an educational technology course. The course provides teacher candidates opportunities to become proficient with a wide variety of technology applications to enhance P-12 student learning, manage the classroom, and assess/reflect on student learning. The class is delivered in a computer lab equipped with thirty student workstations, a teacher workstation, document camera, projector, and screen. The lab is equipped with software that allows an iOS device to be mirrored on the screen. Teacher candidates explore new research in technology including current terminology and are given instruction on a weekly basis as how to ethically and legally use technology in the classroom. Emphasis is also placed on how to use technology to make and administer professional and effective presentations. Candidates are required to develop strategies to enhance lessons by incorporating technology into P-12 instruction and the completion of assignments. An emphasis is also placed on developing candidates' knowledge and skills to actively engage P-12 students with available technologies within their classrooms.

All teacher candidates enrolled in any teacher preparation program at the University of Pikeville are required to complete two courses focused on meeting the needs of students with learning disabilities. In addition, candidates discuss IDEA 2004 in their education courses. In the course Exceptional Learners in the Inclusive Classroom, candidates learn the steps involved in the development of an IEP and the general education teacher's role in each step as candidates role play IEP team meetings. Candidates must also document field hours within P-12 classrooms. Their required field experiences involve classroom observations with diverse groups of students, including students with disabilities and ESL students. The education courses focused on developing pedagogical skills within our teacher education programs integrate strategies for working with students with limited English proficiency or ESL students. Our literacy courses also integrate strategies for working with P-12 students with limited English proficiency.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

In the course Exceptional Learners in the Inclusive Classroom, candidates learn the steps involved in the development of an IEP and the general education teacher's role in each step as candidates role play IEP team meetings to prepare them for their role when they become P-12 teachers. We understand that our preservice teachers must be prepared for this process.

The University of Pikeville provides an effective paradigm of educational beliefs and programming, ensuring a complete array of experiences, knowledge, dispositions, and skills to create success for the graduates of our professional education programs. Serving as a foundation for these beliefs and programs, the organizing theme "Empowering teachers to serve and lead in rural Appalachia and beyond" guides our growth and service. Our conviction that all students have potential to learn at high levels (regardless of exceptionalities and differences), functions as an impetus to facilitate a sense of responsibility and determination in the future teachers we train. This acts as the driving force behind the Patton College of Education at the University of Pikeville. Several elements complement this conceptual framework by defining standards and approaches advocated by the teacher education programs at the University of Pikeville. Teacher candidates are presented with a model of teaching that involves goal-directed planning, observation, and assessment of plans as they are implemented, and the flexibility and skills to continually adapt to the needs, changes, and events they discover. Faculty in the Patton College of Education stress the importance of a broad repertoire of teaching strategies, a pluralistic approach to classroom management, and a model of teachers as decision makers. Teacher candidates learn to approach teaching in this rational reflective manner, relying on a broad knowledge base, multiple areas of competence, and appropriate dispositions to facilitate genuine human relationships and meaningful learning experiences. Candidates enter the teacher preparation programs at the University of Pikeville after they have completed the coursework in their content area majors and educational foundation courses. After admission, the teacher candidates participate in a full professional year. During the first semester of the professional year, we try to help solve the disconnect between the reality of the P-12 classroom and campus courses. Candidates are placed in the appropriate P-12 classroom half-days to learn content-specific pedagogy and classroom skills from master teachers. College professors spend time in the same classrooms and connect what is happening there to their campus classrooms. The second half of the day during the first semester, students are in education courses. During the second semester of their professional year, candidates spend an additional fourteen weeks completing a traditional student teaching assignment. The programs have been designed to enable candidates to complete their professional year and graduate from the institution within four years of entering the University.
