Clarification for responses above: Consistent with the 16 KAR 5:030 on Proficiency Evaluation, when conducting a proficiency evaluation, the faculty may assess proficiency by considering 1) previous education, 2) unusual experience, and 3) the proficiency assessment must be at a level comparable to the usual requirements in the content area in which the educator is seeking certification. If the candidate does not meet all the requirements or is seeking to have additional certification, he/she will work with a member of the Director of Teacher Education and the University Clinical Supervisor to complete an Educator Learning Plan (ELP) that outlines additional requirements needed for the proficiency evaluation. The ELP will be individualized based on each applicant's past education and/or experiences and program area in which certification is sought. Therefore, proficiency evaluation candidates are not required to have a number of clock hours of supervised clinical experience prior to teaching in the P-12 classroom. However, our University Clinical Supervisor observes, mentors, and supports candidates throughout the academic year as they are working to meet the goals in their Educator Learning Plans. While they are serving as the teacher of record, they are assessed, mentored, and supported to ensure high-quality instruction is taking place within the P-12 classroom. Proficiency evaluation candidates are issued a one-year, provisional teaching certificate, which can be renewed one additional year. However, the proficiency evaluation process must be successfully completed within the two-year time period.

The ELP will be individualized based on the applicant's past education and/or experiences and program area in which certification is sought. The ELP will include: 1) specific learning goals and objectives based on the review of evidence submitted and the program area in which certification is sought; 2) required field experiences, which include the completion of classroom observations by UPIKE Faculty demonstrating application of the Kentucky Teacher Performance Standards and application of the Kentucky Framework for Teaching: Planning and Preparation, Classroom Environment, Instruction, and Professional Responsibilities; 3) demonstration of the appropriate

professional dispositions; 4) proficient use of technology applications in education; 5) evidence of addressing the diverse learning needs of students; 6) communication with students, parents, and families; 7) relevant professional learning activities with UPIKE faculty and/or other sources required to reach proficiency level based on review of evidence submitted.
